Arizona allows you to turn your state taxes into tuition scholarships for students enrolled in K – 12 private schools.

2

Arizona Student Tuition Organizations give those funds to **SFX** as tuition scholarships.

When you file your taxes **you get those funds back** by taking the credit off of your AZ state tax liability at zero cost to you.
